## RELEASE AND WAIVER OF LIABILITY FOR MINORS

**NOTICE – THIS IS A LEGAL DOCUMENT THAT CONTAINS A GENERAL RELEASE.  
It should be read carefully and understood fully before signing.**

This Release and Waiver of Liability (the "Release") is executed on this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by \_\_\_\_\_, a minor child (the "Volunteer"), and \_\_\_\_\_, the parent having legal custody and/or the legal guardian of the volunteer (the "Guardian") in favor of Movers & Shakers Furniture Ministry, Inc., a Georgia nonprofit corporation, its directors, officers, employees and agents (collectively, "M&S").

The Volunteer and Guardian desire the Volunteer to work as a volunteer for M&S and engage in the activities related to being a volunteer. The Volunteer and Guardian understand that the activities may include lifting and carrying heavy furniture, working in the M&S warehouse, and travel to and from locations where M&S is performing its ministry services. The Volunteer and Guardian do hereby freely, voluntarily and without duress execute this Release under the following terms:

**1. Waiver and Release.** Volunteer and Guardian do hereby release and forever discharge and hold harmless M&S and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereinafter arise from Volunteer's work for M&S. Volunteer and Guardian understand and acknowledges that this Release discharges M&S from any liability or claim that the Volunteer may have against M&S with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's work for M&S, whether caused by the negligence of M&S, its officers, directors, employees, or agents or otherwise. Volunteer and Guardian also understand that, except as otherwise agreed to by M&S in writing, M&S does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance, in the event of injury or illness.

**2. Medical Treatment.** Except as otherwise agreed to by M&S in writing, Volunteer and Guardian do hereby release and forever discharge M&S from any claim whatsoever that arises or may hereinafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's work for M&S.

**3. Assumption of the Risk.** Volunteer and Guardian understand that the work for M&S may include activities that may be hazardous to the Volunteer, including loading and unloading, carrying furniture in the homes of donors and recipients, going up and down stairs, up and down natural inclines, and transportation to and from donors' and recipients' homes. In connection thereto, Volunteer and Guardian recognize and understands that activities at M&S may, in some situations, involve inherently dangerous activities. Volunteer and Guardian hereby expressly and specifically assume the risk of injury or harm in these activities and releases M&S from all liability for injury, illness, death or property damage resulting from the activities of the Volunteer's work for M&S.

**4. Insurance.** The Volunteer and Guardian understand that, except as otherwise agreed to by M&S in writing M&S does not carry or maintain health, medical or disability insurance coverage for any Volunteer.

**EACH VOLUNTEER IS EXPECTED AND ENCOURAGED TO OBTAIN HIS/HER OWN MEDICAL OR HEALTH INSURANCE COVERAGE.**

**5. Governing Law.** Volunteer and Guardian expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the Sate of Georgia, and that this Release shall be governed by and interpreted in accordance with the Laws of the State of Georgia. Volunteer and Guardian agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
